**Tax Benefits:**

Because FARA is registered as a 501(c)(3) organization, all donations are tax deductible. The table below outlines your tax deduction benefit according to your tax bracket.

| <b>Tax Bracket</b> | <b>Donation Amount</b> | <b>Benefit</b> | <b>Out-of-Pocket Cost</b> |
|--------------------|------------------------|----------------|---------------------------|
| 15%                | \$100                  | \$15           | \$85                      |
| 28%                | \$100                  | \$28           | \$72                      |
| 31%                | \$100                  | \$31           | \$69                      |
| 36%                | \$100                  | \$36           | \$64                      |
| 39.6%              | \$100                  | \$39.6         | \$60.4                    |

Cash contributions of \$250 and over require an acknowledgement that must be sent to the IRS with your tax returns. FARA will provide receipts for every donation, no matter the amount.

The IRS does not require receipts for cash donations under \$250, but you should keep donation information on file. Be sure to keep the check copy, or email receipt from FARA after each donation. Always note the donation amount, the date of the contribution, and the name of our organization, FARA, Fútbol Against Racism in the Americas.

For donations over \$250, each receipt will record the donation amount, the date the donation was made, our organization's name, as well as a written acknowledgement of any property or services that you may have received in return for your donation and an estimate of their value. The IRS should acknowledge an email receipt as an acceptable record of donation, but to be certain, always consult your tax advisor.

**Option to receive services for donations (Page 1):**

For those companies and organizations interested in receiving benefits in return for their donations, all tax deductions are valued at the difference of total donation amount minus the value of the FARA services rendered.

Your company or organization, however, can choose whether or not to receive such donor privileges, by checking the appropriate box on the Donation Form. By checking the "Opt out" box, all donor benefits related to sponsorships can then only be transacted through normal corporate procedures. Thus, your entire donation will then become a tax deduction.
